Human Services

- **Combating Child Exploitation** - On Wednesday, June 3, Gov. Jared Polis signed Senate Bill 26-015, a new state law that strengthens Colorado's response to child exploitation and human trafficking. Douglas County Commissioner Abe Laydon—who championed the bill throughout the legislative session—joined advocates from across the state at the bill-signing ceremony.



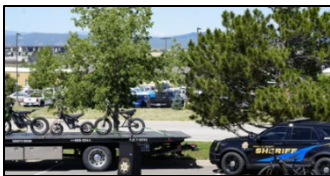
What The New Law Does

- Requires mandatory jail time between 4 and 12 years for six crimes involving the commercial sexual exploitation of a child. Previously, offenders could be eligible for probation.
- Expands sex-offender registration requirements for certain offenses.
- Modernizes outdated legal language by replacing terms such as “child prostitution” with “commercial sexual activity with a child,” reinforcing that minors cannot consent and must be treated as victims.
- Adds stronger penalties for offenders who use the internet to target children.
- Most sentencing changes take effect July 1, 2026. Updated legal terminology takes effect immediately.

The Board of County Commissioners also lobbied for a similar federal bill in Washington, D.C., demonstrating Douglas County's commitment to protecting children and combating human trafficking at both the state and national levels. [Read More](#)

Sheriff's Office

- **Proposed Ordinance on Electric Dirt Bikes** - Public safety is our top priority, and today we're asking for your help in sharing an important message with our community. Douglas County Commissioners are currently considering a new ordinance addressing high-powered electric dirt bikes, which are increasingly being ridden by young, inexperienced riders in public spaces. Calls for service are rising, and community concerns are growing. During our recent enforcement efforts, many of the riders contacted were between 12 and 14 years old.



Many people mistakenly believe these vehicles are standard e-bikes. They are not. Unlike traditional e-bikes with functional pedals, these high-powered electric dirt bikes operate solely by throttle, and certain models can reach speeds of up to 75 mph. They are often being ridden on roads, sidewalks, trails, and bike paths where they are not legally permitted. Emergency room personnel are also seeing a growing number of serious injuries involving young riders. [Read Full Story](#)

At their Tuesday, June 9, Business Meeting, the Board of County Commissioners approved the first reading of a new ordinance that would regulate low-powered scooters and off-highway vehicles (Passes 3-0).

The proposed ordinance comes in response to growing safety concerns involving the operation of certain motorized vehicles on public roads, trails and other public property throughout Douglas County. The ordinance is being proposed in partnership with the Douglas County Sheriff's Office, which will also be responsible for enforcing the ordinance if approved. Officials have seen an increase in incidents involving vehicles that are not legally permitted to operate the same way as traditional bicycles. The second reading and consideration of the ordinance will take place at a future Business

Office of Emergency Management

- Staff participated in several wildfire-themed town halls and education sessions to help citizens prepare for wildfires.
- Work continues toward developing and implementing evacuation zones through Douglas County and our Municipalities.
- Douglas County Helitack assisted Search and Rescue with locating two missing hikers in the Bear Mountain area.
- Staff participated in a Red Cross regional shelter exercise aimed at improving shelter response and coordination.
- Staff attended as an honored guest at the Red Cross Heroes Gala.
- Staff instructed ICS-400 Incident Management to multi-jurisdictional partners in Larkspur.
- Work continues toward updating and improving OEM plans and the EOC upgrade project.



Community Services

Activity Report for June 4 – June 18, 2026

- **Celebrating Unity on Wolfensberger** - On Thursday, June 4, Douglas County Commissioner George Teal joined community leaders and the Wellspring team to celebrate the opening of Unity on Wolfensberger, a unique independent housing project that gives adults with intellectual and developmental disabilities (IDD) the opportunity to purchase their own condominium.



Since 2001, Douglas County has dedicated a one mill property tax to support residents with IDD: the [Developmental Disabilities Mill Levy](#). In early 2026, the County announced that \$2.5 million in DDML revenues would be reserved to launch an IDD Supportive Housing Grant Opportunity, with the goal of expanding independent living options for adults with IDD. Wellspring was selected as the top-ranked grant applicant for the Unity on Wolfensberger project. Along with the 24 for-sale residential units, the entire first floor will house a community swimming pool, additional resident amenities and the Wellspring offices.

- **Douglas County Opens Applications for 2026 Developmental Disability Mill Levy Grant Program** - Organizations serving Douglas County residents with intellectual and developmental disabilities (IDD) can apply for funding through the 2026 Developmental Disability Mill Levy (DDML) Grant Program beginning **June 15**.



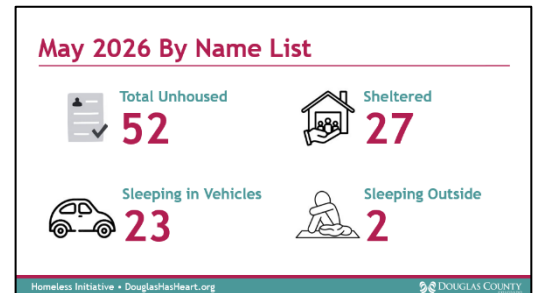
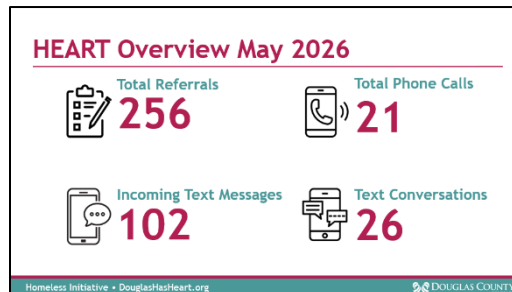
Since 2001, Douglas County has invested more than \$6.8 million through the DDML Grant Program to support services, programs and opportunities that improve the lives of residents with intellectual and developmental disabilities. [Visit our webpage to learn more and to apply.](#)

- **Expediting Affordable Housing** - At their Tuesday, June 9, Business Meeting, the Board of County Commissioners voted to approve the Resolution Establishing Expedited Review Policies for Affordable Housing Projects (Passes 3-0).
 - In 2022, Colorado voters approved Proposition 123, establishing the State Affordable Housing Fund to increase affordable housing throughout Colorado.
 - In 2023, the Board approved a commitment to increase affordable housing stock by 3% annually over 3 years. The commitment secured eligibility for Proposition 123 funds.
 - For continued eligibility, the County must adopt a Fast-Track policy expediting affordable housing project reviews.
 - Developments with 50% or more affordable housing units must receive a final decision within 90 days of submitting a complete application.
 - The resolution recognizes that the County's existing regulations meet the 90-day requirement.

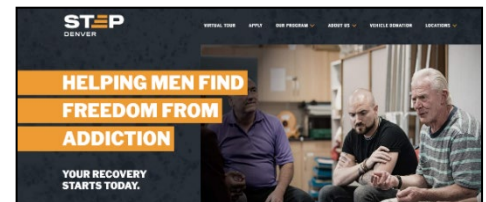
- **HEART May 2026 Report:**



- **HEART Success Story** - Castle Rock Police contacted HEART after observing a man sleeping outside the Help and Hope Center in Castle Rock. A HEART Navigator and Deputy engaged with the male after he accessed clothing and food through Help and Hope. He shared that he had been experiencing homelessness for about a year and was seeking a structured program that could support long-term stability.



Staff provided information about Step Denver, including program expectations and what to expect during the intake process. The individual completed a phone interview with Step Denver, and staff scheduled an in-person meeting for later that day. The Navigator and Deputy provided transportation to Denver so he could complete the intake. Upon arrival, he was welcomed by staff and was later accepted into the program. HEART offered meaningful support at a time when he had been facing significant challenges, including his vehicle being towed and the loss of his personal belongings. Their assistance helped create a pathway toward stability and hope despite recent setbacks.



Outreach and Engagement

- **Coffee With a Cop** – On June 10, the HEART team joined the Lone Tree Police Department for “Coffee with a Cop” at the Lone Tree Recreation Center. These gatherings offer a welcoming setting for community members to connect with local law enforcement and learn about the HEART program. These events help increase public awareness of HEART and provides guidance to community members on how to contact the team when they see someone in need.
- **Via TransitTech Executive Summit (TES)** – Members of Community Services staff attended the Transit Tech Executive Summit hosted by Via Transportation in Cherry Creek on June 2 and 3. The two-day summit included sessions on the latest in transportation service trends and opportunities; including sessions on driverless vehicles, updates to Via’s software and reporting tools, case studies from other communities, and a legislative update. Commissioner Laydon presented on the success of Link in Highlands Ranch to those in attendance.



Parks and Recreation

- **Celebrating Toepfer Park** - On Monday, June 1, the Board of County Commissioners joined community leaders in Highlands Ranch to celebrate the completed improvements to Toepfer Park.



In 2022, the Board, in partnership with the Douglas County School District, conveyed 10 acres of land to the Highlands Ranch Metro District to support park enhancements. Between 2023 and 2025, residents helped guide the project through public meetings and surveys, leading to final plan approval by the Metro District Board and the Douglas County Planning Commission in early 2025. Construction began in May 2025 and brought an expanded playground, a new shade shelter, a new loop trail, updated lighting, and new benches, grills, bike racks and picnic tables. Parks Programming

- **Synthetic Turf Replacement** - Fields E & F (West Fields) at Highland Heritage Regional Park have been identified for replacement this year. Academy Sports Turf has been selected as the vendor following the staff's comprehensive review of the synthetic turf products currently on the market. A pre-construction meeting for the replacement of synthetic turf was held on 6/11, with work scheduled to begin on Friday, June 19th. Removal of the old fields and installation of new synthetic turf will take approximately 6 weeks to complete.



Park Operations

- **Water Restrictions** - Staff have been actively managing the various water restrictions implemented by

water providers in response to the drought Colorado is currently experiencing. With properties spread across the County, Parks staff must work with six different water providers for irrigation usage. Currently, some providers have restricted irrigation to three times a week, and others have restricted it

to two times a week. Parks staff have programmed all irrigation to comply not only with scheduled days but also with the allowed watering windows.

Rueter-Hess Recreation

- **Rescue at Rueter-Hess Reservoir** - On June 2, 2026, County staff responded to a youth camp operating



kayaks on Rueter-Hess Reservoir that required assistance due to strong winds and hazardous water conditions. The Douglas County Sheriff's Office and South Metro Fire Rescue also participated in the response. Fortunately, the incident concluded without any loss of life or serious injuries. This event highlighted the importance of rapid interagency coordination and prudent decision-making to ensure the safety of our visitors.

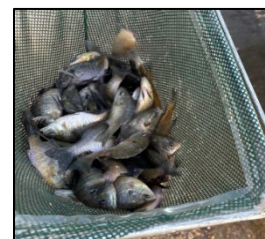
- **Rattlesnake Avoidance Training Event at Rueter-Hess** - The Colorado Gun Dog Association held its annual Rattlesnake Avoidance Training event at Rueter-Hess on Saturday, June 6, 2026. This year, nearly 285 dogs and their owners participated in the training as they walked a course designed to simulate rattlesnake habitat. This type of training is crucial for those who enjoy hiking along the Front Range. According to the Colorado State University Veterinary Health System, its emergency room treats between 3 and 5 rattlesnake bites each week during the warmer months. - **Rueter-Hess Reservoir Fish Stocking** - The fishery at Rueter-Hess Reservoir has recently improved! On June 9, 2026, Parker Water and Sanitation, Douglas County, and the Rueter-Hess Recreation Advisory Board stocked nearly 5,500 fish, including Bluegill and Largemouth Bass. The primary goal of this fishery management is to enhance water quality, with recreational fishing serving as a secondary benefit. The stocking took place in the late evening to minimize stress on the fish and reduce pressure from predators. The details of the stocking are as follows:



- 4,000 Bluegill measuring between 2-3 inches
- 1,000 Bluegill measuring between 4-6 inches
- 500 Largemouth Bass measuring between 4-6 inches



Strategic Solutions

Douglas County Use Case Spotlight

- **Automating Wildfire Mitigation Agreements, Office of Emergency Management** - Dylan Williams, Wildfire



Mitigation and Resilience Coordinator, used ChatGPT to automate the creation of 88 Wildfire Mitigation Cost-Share funding agreements. What would have been hours of manual copy-and-paste work was completed in minutes, with all agreements generated accurately and consistently from a spreadsheet and contract template.

The Challenge: Each award recipient required an individual funding agreement populated with applicant, property, contractor, and award information. Creating 88 agreements manually was repetitive, time-consuming, and susceptible to data-entry errors.

The AI Solution: Dylan uploaded the awardee spreadsheet and funding agreement template into ChatGPT and used a structured prompt to:

- Analyze and map spreadsheet fields to contract fields.
- Validate the mapping before processing.
- Generate one completed agreement per recipient while preserving all contract language and formatting.

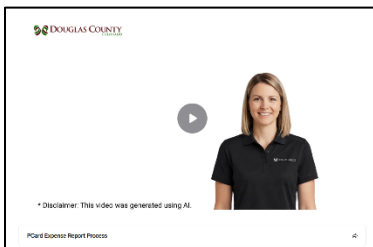
ChatGPT produced a ZIP file containing all 88 completed agreements.

Results & Benefits:

- Generated 88 completed agreements automatically.
- Saved hours of administrative work.
- Reduced manual data-entry effort and potential errors.
- Enabled staff to focus on higher-value program activities.

Team Reflection: *"It seriously saved me so much time. I'm already thinking of other ways I can use AI to make my workflows more efficient."* — Dylan Williams, Wildfire Mitigation & Resilience Coordinator

- **AI Helps Create P-Card Training Video** - A nearly eight-minute P-Card Expense Report training video was recreated using an AI-enabled video creation tool, turning existing transcript content and completed screenshots into a professional, step-by-step learning resource for employees. The video guides users through the D365 P-Card expense report process, including selecting imported card transactions, attaching receipts, validating accounting information, and submitting the report for approval.



With the provided transcript and screenshots, the video took approximately three to four hours to complete. The work demonstrated that AI-generated avatars and voiceovers can significantly reduce the time and effort traditionally required to create training videos, enabling business users to create professional-quality training content without specialized video production skills, voice recording, or repeated rehearsals.

The benefits are both immediate and scalable. The County avoided additional vendor costs and lead times, reduced the time required for future edits, and created a training asset that is easy to maintain instead of re-recorded in full. More importantly, the project showed how AI can help preserve institutional knowledge, reduce vendor dependency, and make high-quality training content easier for departments to produce and maintain.

Community Development

Activity Report June 3 – June 16, 2026

Planning - Historic Resources

- **Tours of Archaeological Excavation at site 5DA265** - The County Curator gave tours of the State Historic Fund grant excavation project of site 5DA.265. The County was awarded \$250,000 with cash matching funds of \$62,500 for this project.



The public tours occurred June 2 through June 4. On June 5, the tours consisted of County staff, County Open Space Advisory Committee (COSAC), Parks Advisory Board (PAD), and Historic Preservation Board (HPB) members. All the tour groups were given an overview of tribal history in the area over the past 13,000 years. Retired archaeologist Reid Farmer helped give the tours along with the archaeologists on the project, Jon Hedlund and Kevin Gilmore. The tour groups received background information of the site and had interactions with the principal investigator archaeologists on the project. Previous excavated artifacts were passed around for viewing along with some new artifacts from the current project. During week one of the field work around 2,000 artifacts were recovered along with the discovery of several oven hearths. The excavation portion of the project will take approximately 2 weeks.



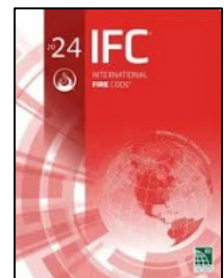
- **Historic Resources Booth at Castle Rock Flag Day Event** - Historic Resources staff hosted a booth at the Town of Castle Rock's Flag Day Event on Sunday, June 14 at the Castle Rock Farmer's Market. The event provided a great opportunity for staff to engage with the public and promote the series of County events scheduled for the 250th celebration of America and the 150th celebration of Colorado. Staff brought artifacts from the Douglas County Repository to share with the public.



Public Works

Activity Report May 26 – June 5, 2026

- **Updating Fire Code:** At their Tuesday, June 9, Business Meeting, the Board of County Commissioners **approved the first reading of an ordinance to adopt 2024 International Fire Code** (Passes 3-0). Key Updates:
 - **Adds new building materials** and construction methods
 - **Provides consistency** with neighboring jurisdictions
 - **Enhances public and firefighter safety**
 - Supports strong Insurance Services Office (ISO) ratings for Douglas County and our fire protection districts
 - **Clarifies permit requirements** for outdoor events
 - **Adds inflatable amusement devices** (ie. bounce houses)
 - Adds an exception for hyperbaric facilities
 - Removes amended fire-flow table for commercial and multifamily buildings



The second reading and consideration of the ordinance will take place at a future Public Hearing.

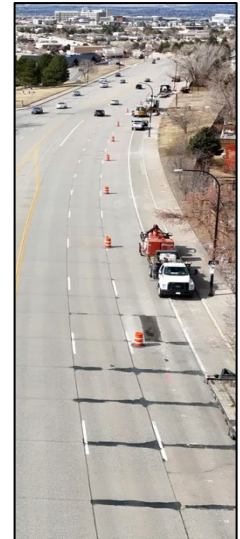
- **[Hilltop Road \(Legend High School to Crest View Drive\) Improvements Project](#)** – For segment 1 of this project, construction began on April 16, 2025 and crews began paving operations on March 9, 2026. This is the first of three projects planned over the next few years to reconstruct and widen the Hilltop Road and Singing Hills Road corridors. The project has a 16-month completion date and is anticipated to be finished in September 2026. Phase 2 of construction is anticipated to begin in 2027; and will take 9 to 12 months to construct. Phase 3 of construction is anticipated to begin in 2029 (pending funding); and will take 12 to 18 months to construct. [Roundabout Rendition/Map](#)
 - Upcoming traffic shift – In the next month, motorists can expect a traffic shift on Hilltop Road between Legend High School and Crestview Drive. Traffic will shift to the north to the newly paved traffic lanes. Stay tuned for more information on when this shift is expected to occur.



- **Highlands Ranch Parkway Reconstruction Project** – Douglas County began reconstructing Highlands Ranch Parkway between Broadway and Burntwood Way in June 2026. The roadway, originally built in the early 1980s, has reached the end of its useful life, making full reconstruction the most cost-effective solution.

The project will improve safety, accessibility and long-term durability by replacing pavement, curb, gutter and sidewalk; adding a new raised median; upgrading ADA curb ramps; installing a new traffic signal at Ridgelen Way; and replacing the signal at Burntwood Way. Construction is expected to begin June 8, 2026, and end early October.

The project is fully funded through Douglas County maintenance funds. Castle Rock Construction Company of Colorado, LLC will serve as the contractor, with a project cost of \$6,579,818. 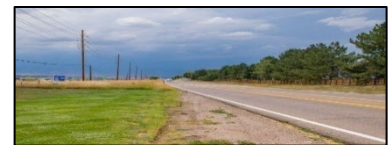
- **[Pine Drive/Pine Lane Improvements Project](#)** - Construction began on Monday, April 6, 2026. The speed limit is lowered to 30 mph throughout the project corridor.



Residents along Pine Drive near Lincoln Avenue may notice an increase in construction activity and noise as crews will begin installing pipe on Monday, May 18. Traffic shifted slightly on Pine Drive near Lincoln Avenue, to allow crews to work on the landscaped median on Pine Drive. This temporary traffic alignment will remain in place for approximately two weeks.

- **I-25 Douglas County Monument Signs** – Cushing Terrell continues to work on the I-25 Monument Sign project. Cushing Terrell continues to work on the I-25 Monument Sign project. The north entry sign has completed the CDOT preliminary review. The project team has survey data and expects geotechnical data soon. They are completing the final design and will adjust with the geotechnical investigation data. The next step is to resubmit structural plans for final CDOT review. The targeted construction date is late summer. The design team is currently addressing the CDOT request for structural details on the RTD bridge sign. The preliminary CDOT review of the south entry sign is also complete and the next steps include survey and a geotechnical evaluation. Pending survey results, the south sign will likely require a review by FHWA. Recent coordination with CDOT indicates no design character changes are required, and major comments for all sites are expected to be resolved in the next submittal.

- **[County Line Road Widening and Reconstruction \(University to Broadway\)](#)** – Construction on County Line Road began in September 2025. Pothole repair work occurred on May 28 throughout the project. Work continues on the noise walls, drainage systems, horizontal concrete work and paving.



- **[Crowfoot Valley Road and Macanta Boulevard Traffic Signal Project](#)** - Douglas County will be installing a new traffic signal at the intersection of Crowfoot Valley Rd and Macanta Blvd to address traffic issues at this intersection. The construction of this project started on April 13, 2026, and is anticipated to be completed by August 6, 2026. The travel lanes on both Crowfoot Valley Rd and Macanta Blvd will be restricted to one lane in all directions, following construction, which began on May 4.



- **Highlands Ranch Pkwy Reconstruction, Broadway to Burntwood** – The project bid on April 8th and Castle Rock Construction Company was the apparent low bidder and was 43% less than the engineer’s estimate. This project includes the reconstruction of the pavement, sidewalk, curb and gutter along the corridor. Additionally, a new median will be constructed, new signals will be constructed at Highlands Ranch Parkway and Ridgelen, and the signals at Burntwood will be replaced. The construction contract is scheduled to be heard by the BCC on May 12th. Construction is scheduled to begin in early June and end by October.



- **Dakan Road Bridge Replacement Project** – Coming soon. Douglas County Engineering staff is currently completing design for the replacement of the Dakan Road Bridge. This project consists of demolition of the existing structure and replacing 151 feet of bridge over West Plum Creek, as well as 1,750 feet of roadway improvements. The project includes removal and replacement of the present structure, hot mix asphalt, erosion control, site restoration, traffic control as well as other roadway items. The proposed structure will be built to the north of the existing structure, thereby allowing the existing structure to remain open to the traveling public and emergency service vehicles during construction. The anticipated construction start date is late spring/early summer 2026.



- **Highlands Ranch Fiber Improvements** - Several utility companies — CenturyLink/Lumen, Comcast, Google and BAM Broadband — are independently installing new or upgrading existing fiber optic networks throughout Highlands Ranch as part of broader broadband expansion efforts. Construction associated with these projects is expected to continue through spring 2027.



While Douglas County is not responsible for these installations, the County has established a fiber information hotline and email to help residents identify the correct utility provider when questions or concerns arise regarding construction, repair or maintenance activities. These include:

- Connecting residents with the correct utility company contact when they have questions about fiber construction, repairs or maintenance occurring in their area.
 - Addressing communication gaps when residents are unable to obtain information directly from the providers, ensuring the public has access to the most current and accurate information available.
- **Waterton Road and Middle Fork Street Roundabout Project** - Douglas County is adding a second roundabout beginning with the south half, then proceeding to the north half. Detours will be in place as needed, and one lane in each direction on Waterton Road will remain open during construction. Construction began on March 30, 2026 and is anticipated to be completed on August 7, 2026. [Detour Map \(Waterton and Middle Fork\)](#) & [Detour Route Map \(Snake River and Eagle River\)](#)



- **Highlands Ranch Drainage Projects**
 - **Douglas County Geopolymer Storm Sewer Project:** Douglas County will be finishing up the Rampart Range Geopolymer Pipe Lining by June 19, 2026. A second crew started Geopolymer Pipe Lining work at Quebec Street and Timberline starting June 1, 2026. The southbound outside lane on Quebec Street will be closed for the next 10 weeks between Collegiate and Trailhead to allow the contractor to conduct the geopolymer lining of the storm sewer within Quebec Street.

- **Douglas County UV Lining Project:** Douglas County will be UV Lining a 60" storm sewer at 8664 Quebec Street, which is the signalized intersection for the shopping centers south of Business Center/Park Meadows Drive starting next week. The bike lane on the northbound lanes will be closed between Chestnut Hill and the shopping center access (Kohls) will be impacted. The west bound lanes of access point to the east (Kohls) will be reduced to a shared lane where all traffic movements will be in the left turn lane only and there will be minimal traffic impacts on the west access point and those impacts will affect the westbound lanes on an as needed basis. Upon completion of the UV lining, construction crews will be moving to County Line, just west of University and we will be extending the right lane closure on County Line from the County Line Widening Project to the University intersection.



- **Jones Road** – Matrix Design Group was selected as the design consultant for the Jones Road project. The project includes asphalt paving of the roughly 3-mile road as well as drainage improvements. The project will be constructed in phases. Staff are reviewing the 90% plans for phase one while Matrix continues to work on phase two. Final design for the remainder of the project is expected by the end of the year.

- **2026 Pavement Management**

- **2026 Sidewalk Repair Project** - If sidewalk or concrete repairs are needed, the first phase will consist of these repairs, which will be performed by the County's sidewalk repair contractor. Sidewalk repairs usually take between 2 and 4 weeks per neighborhood; work on a single block will generally take 3 to 4 days. For a specific list of 2026 Projects, please see the [webpage](#). Construction dates will be updated on each Project's map link, once the schedules are determined.



- The **2026 Guardrail Repair Project** began in April with Cruz Construction. Guardrail repairs continue with the latest completion on Hess Road.



- **The 2026 Asphalt Overlay Project** was awarded to Martin Marietta Materials, Inc. Construction began on April 20 and is anticipated to be completed in August. Work continues in Deerfield and on Spruce Mountain Rd.

- The **2025 Concrete Crushing project** is complete. As the sidewalk project removed and replaced concrete, the old concrete is stockpiled at the Moore Road facility. The County contracted with Western Wrecking to crush the concrete into Class 6 base course. The base course will be used on future road and sidewalk projects. The concrete removed during repairs is 100% recycled and reused. The project produced roughly 38,000 cubic yards of recycled concrete base course.



- **2023 Bannock LID** - FirstBank withdrew their offer to fund the Bannock LID. The County will send out a new request for proposals for financing in July. The design team is still working on completing final design and specifications for bidding. (Design work performed in advance of finalizing financing will be reimbursed to the County by the lender as part of the construction loan.)



- **2023 Spring Canyon LID** – FirstBank withdrew their offer to fund the Spring Canyon LID. The County will send out a new request for proposals for funding to private lenders in July. The design team is still working on completing final design and specifications for bidding. (Design work performed in advance of finalizing financing will be reimbursed to the County by the lender as part of the construction loan.)



- **Country Club Group 10 LID** - FirstBank withdrew their offer to fund the Country Club (Group 10) LID. The County will send out a new request for proposals for financing in July. TST Infrastructure has received survey data but is not moving forward with the design. (Design work performed in advance of finalizing financing will be reimbursed to the County by the lender as part of the construction loan.)

- **Grigs Road Paving Project – Phase 2** - RS&H was selected as the design consultant for phase 2 of the Grigs Road project. Phase 2 will start where phase 1 ends, near the East-West Trailhead Parking Lot and will continue north onto the existing concrete road. The project includes realignment of the road, drainage improvements, a parallel pedestrian trail, and asphalt paving. The consultant has developed concept-level designs for the roadway and adjacent trail. A virtual open house is being developed to share the concept designs and solicit feedback from the public. Survey and geotechnical work continue. This project is scheduled to be constructed in 2027.

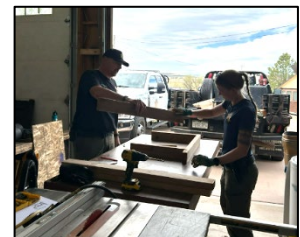


- **Quebec and Park Meadows Dr Intersection Improvements** – The signing and striping project bid on May 26th. The County received one bid from Colorado Barricade in the amount of \$94,888.00, which was 30% below the engineer's estimate. This project will make quick improvements to the intersection by refreshing the pavement markings and adding signage. The final design of the larger construction project has started with Basis Partners. All data collection is complete, and Basis Partners anticipated beginning design this month. Construction is planned for 2028.



Open Space and Natural Resources

- **Artifact Sifting Screen Construction for Archaeological Excavations with Historic Preservation** - Open Space and Natural Resources (OSNR) staff constructed new artifact-sifting screens utilizing spare materials from the woodshop at Prairie Canyon Ranch Open Space. The artifact screens will be used by staff and volunteers from Planning's Historic Resources (HR) Division to support upcoming archaeological excavations on Open Space properties. These tools will sift ground soil to uncover cultural artifacts dating back centuries.



- **History Tour at Sandstone Ranch Open Space with the Lone Tree Living and Aging Well Commission** - On June 10th, OSNR staff led a history tour on the guided access side of Sandstone Ranch Open Space for the Lone Tree Living and Aging Well Commission. The group visited the site's historic barns and structures, where staff highlighted ongoing preservation work conducted in partnership with the division of Historic Preservation. The tour also included a visit to the ranch overlook, where OSNR staff provided interpretation of the area's billion-year-old geology and diverse wildlife habitats. For many participants it was their first visit to Sandstone Ranch Open Space, emphasizing OSNR's mission to provide meaningful and accessible educational opportunities for all Douglas County residents.

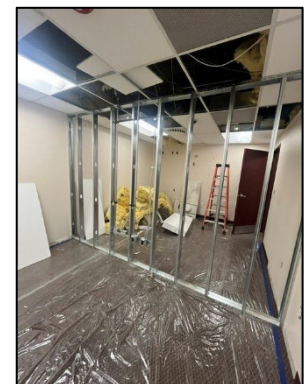

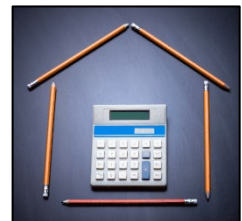
Information Technology

Completed IT Projects/Initiatives

- **Modernizing County Fuel Management Infrastructure** - Douglas County Information Technology (DCIT), in partnership with Fleet Services, successfully completed the FFESS Fuel Management System Replacement. This project replaced the County's aging fuel management system with a modern solution across all nine fuel sites, helping ensure continued reliability and support for daily fuel operations. The new system reduces risks associated with outdated equipment, improves security, and provides a more dependable platform for managing County fuel services. The project was completed ahead of schedule and budget.



- **Deed Processing Automation** - Douglas County Information Technology (DCIT), in partnership with the Assessor's Office, successfully launched a **new** Deed Processing Automation system. The new system automates key aspects of deed processing using **AI-powered data extraction**, reducing manual data entry, improving data quality, and streamlining workflows to support fair and accurate property records. The project team is currently providing post-implementation support to ensure a smooth transition and successful user adoption.

Commissioner Meetings – June 9, 2026: Work Session - Various

- **Frank House Historic Preservation Funding Request** - The Board reviewed a request from the Town of Larkspur for \$800,000 to assist with the acquisition of the Frank House, a county-designated historic property proposed for use as a civic and community gathering space. Larkspur indicated it would contribute \$300,000 toward the purchase and assume all future maintenance and operational responsibilities. Staff received direction to coordinate a site visit prior to future deliberation on the proposal.
- **Douglas County Fairgrounds RV Infrastructure Expansion** - The Board discussed a proposal to additional RV electric hookup pedestals to the Douglas County Fairgrounds. Staff received direction to work with CORE to develop potential project scope and cost estimates, and to evaluate how additional RV infrastructure could be incorporated into the Fairgrounds Master Plan.
- **Highlands Ranch Independence Day Celebration** - Following the Highlands Ranch Metro District's decision to cancel its traditional Fourth of July celebration, the Board discussed options for a county-supported Independence Day event serving Highlands Ranch residents. The Board directed staff to proceed with event planning and directed staff to consult with the Sheriff's Office regarding staffing and safety requirements, contact drone show vendors to assess availability as a potential alternative to fireworks, and coordinate with the Highlands Ranch Metro District (HRMD) and Highlands Ranch Community Association (HRCA) regarding logistics, traffic management, and event support.
- **Event Fee Waiver Request** - The Board considered a request from Rocky Mountain Gun Owners to waive event-related fees associated with use of county facilities. After discussion, commissioners approved a partial fee waiver, eliminating the \$1,500 setup-day fee while retaining all standard event-day charges.
